If you would like to take part in these tests with one or more samples, please inform us of your intention by email to epm@bast.de until 18th December, 2023 the latest. Your application for paints should state the number of road marking systems and include the following details:

- Type of marking (I or II)
- Kind of marking (high solid, water-based paint)
- Application device (airless, compressed air, etc.)
- Class of roughness of the test plates (RG 1 or RG 2)



Your application for tapes should state the number of road marking systems and include the following details:

- Type of marking (I or II)
- Type of tape (flat, profiled)
- paint (white, yellow)
- Class of roughness of the test plates (RG 1 or RG 2)

Please use the corresponding attached application form for registration. In addition, please send us the safety data sheets for the intended road marking material.

Please note that your application can only be accepted with safety data sheets.

We draw attention to the fact that the test places will be given according to the order of registration and the type of application. Subsequent changes might cause that the sample is shifted to another test run.

Several test runs take place depending on the need. The results are sent once all test runs have been completed. We try to meet your needs and therefore ask you for realistic information regarding the number of samples.

You will be informed immediately about the further procedure and your possible participation or the number of samples made available to you after the allocation has taken place.
